Pen Cards will be provided relating to Performance EBVS and Lineage, however Health Status Cards will need to be requested by the Vendor, from their appropriate Health Scheme Provider. In all cases the information provided in the Catalogue and on Pens will be taken as that held by the Beef Shorthorn Society Breedplan System on the date of printing.
